#### **Teamwork**

The Health Department is composed of many divisions, including Administrative, Environmental, Fiscal, Nursing, and Preparedness. While each division has different responsibilities, they work together to meet our mission to serve and educate the citizens of Hocking County with public health programs that prevent disease, promote healthy lifestyles and protect the environment.



#### **Environmental Health**

In April we welcomed Chance Graham as a new Registered Environmental Health Specialist in Training. Chance has a Bachelor's Degree from West Virginia University in Wildlife & Fisheries Resources. In November we welcomed John Blazer as a new Registered Environmental Health Specialist in Training. John is a veteran of the Marine Corps and obtained his Bachelor of Science in Wildlife Management from the University of Rio Grande.

In 2022 we helped 45 homeowners through the WPCLF program for their sewage treatment system or sewer lateral connection. \$1,938,148.21 of monetary assistance has been received through grant funding since 2010.

90 contractors participated in our annual Contractor's Workshop held on April 7. This workshop is held so sewage treatment system contractors can obtain their required 6 hours of continuing education.

#### Lead

Throughout 2022 the number of cases of lead poisoning in our communities' children has increased. With this increase, the Hocking County Health Department is reaching out to do its part in educating about lead-based hazards. The health department aims to increase knowledge of lead and lead concerns and looks forward to adding lead education to community outreach programs.

We plan to provide reminders of the importance of testing all children between the ages of 1-5 years old for lead poisoning, which includes ongoing testing if warranted, and explain lead abatement and lead abatement funding opportunities to community members. We have been working diligently with the state of Ohio and have requested a professional-grade HEPA vacuum to loan out to assist the residents of Hocking County. This year the CDC has also initiated lower standards of acceptable lead levels with the knowledge of how lead affects children. The Ohio Department of Health is adopting these new standards, which decrease an acceptable lead level from under 5µg/dL to under 3.5µg/dL.

#### Tobacco Use, Cessation, and Prevention

The Hocking County Health Department's tobacco prevention program continues to expand cessation services in Hocking County. Our mission is to decrease the burden of tobacco use for Hocking County citizens through tobacco prevention and cessation programs, disease prevention education, promotion of a healthy lifestyle, and protection of the environment. The program recently met with local medical providers to increase referrals to the Ohio Tobacco Quit Line, which now offers free nicotine replacement therapy to those who complete counseling calls. The program continues to partner with the Logan-Hocking School District to educate students and staff on the importance of remaining tobacco-free and the dangers of vaping/e-cigarette use. Lastly, the program utilized several media channels for outreach throughout the county. Social media, billboards, placemats, newspapers, newsletters, and participation in community events such as Kidpalooza, Trunk or Treat, and the Christmas parade.

# **Emergency Preparedness**

#### **Grant Funding**

Funding was received through several grants to assist with emergency preparedness activities. The health department received the Public Health Emergency Preparedness (PHEP) grant and the CDC Cities Readiness Initiative (CRI) grant.


The PHEP grant is a critical source of funding for local public health departments. The grant has assisted public health departments across the nation to build and strengthen their abilities to effectively respond to a range of public health threats, including infectious diseases, natural disasters, and biological, chemical, nuclear, and radiological incidents.

The CRI grant is a federally funded grant that enhances preparedness in the nation's largest population centers. This grant prepares metropolitan jurisdictions to effectively respond to large public health emergencies with life-saving medicines and medical supplies. Public health departments use this grant to develop, test, and maintain emergency response plans.

The health department participated in numerous readiness exercises and training, including facilitating the tabletop exercise: "Once Upon A Cold and Wintry Night..." which focused on Emergency Public Information and Warning, Mass Care, Responder Safety/Health, and Volunteer Management.

# **Medical Reserve Corps**

#### **Grant Funding**



Through this funding, the health department has been able to build operational readiness capabilities of the Hocking County MRC unit. Including building capacity for the MRC to respond, innovate to evolving requirements, sustain staffing requirements, and equip MRC units with resources needed to support their mission. Efforts to develop and strengthen MRC capabilities, raise stakeholder awareness of MRC capabilities, and identify or sustain the integration of the MRC unit into local, state, and regional emergency response plans have also occurred.

The Hocking County MRC Unit provided free training opportunities to all MRC volunteers. Through recruiting efforts, MRC membership increased by 36%.


