


#### **Mission**

Our mission is to serve and educate the citizens of Hocking County with public health programs that prevent disease, promote healthy lifestyles and protect the environment.

#### **Vision**

The vision of the Hocking County Health Department is to achieve excellence in health education, disease prevention and environmental health. It is our desire to provide high quality, community friendly, accessible services that reflect our mission in accordance with the Public Health Standards, and make the Hocking County Health Department become recognized as a model public health agency.



#### **Environmental Health**

#### **Programs**

In 2024, the plumbing program conducted approximately 393 inspections, driving 6,213 miles. The sewage and new building programs totaled 729 inspections, driving 11,029 miles. The private water program encumbered approximately 314 inspections and sample collections, driving 2,976 miles. The food safety program encumbered approximately 429 inspections, driving 2,641 miles. Recreation campground and pool program inspections totaled approximately 115 inspections, driving 854 miles.

#### **Mosquito Control Grant**

We Hired 2 interns for our summer mosquito program. Mosquitos were collected and sent to the Ohio Department of Health for testing and identification. The interns also conducted pesticide resistance testing to determine if any mosquitos had become resistant to pesticides. We will apply again for 2025 for this grant from the EPA to continue collecting and testing mosquitoes, to larvicide to control mosquito populations, and to help educate our residents and visitors on how to prevent mosquito-borne diseases and to expand our tick collection and population monitoring.

#### **Sewage Grant**

We continue to administer the Water Pollution Control Loan Fund (WPCLF) from the Ohio EPA to assist homeowners in repairing or replacing their failed sewage treatment systems (STS). Since 2010, we have helped 365 residents and received \$2,288,300.06 through the WPCLF program, which has greatly improved the public health of Hocking County Residents.

#### **Immunizations**

In recent years, many regions have seen fluctuations in immunization rates. Factors contributing to these changes can include public awareness campaigns, access to healthcare, socioeconomic conditions, and, unfortunately, the spread of misinformation regarding vaccine safety. For instance, specific communities may experience lower vaccination rates due to vaccine hesitancy, which can lead to outbreaks of vaccine-preventable diseases.

Efforts to improve these rates often involve educational initiatives to inform communities about the importance of vaccinations and programs designed to increase access to vaccines, such as the Vaccines for Children (VFC) program.

The Hocking County Health Department participates in the VFC program. The VFC program is a federally funded program overseen by the CDC and administered in Ohio by the Ohio Department of Health. It supplies vaccines free to public and private healthcare providers who enroll and agree to immunize eligible children in their medical practices.

In addition to the VFC program, the Health Department works closely with the Logan-Hocking School District to ensure students have all the required school immunizations. High immunization rates are essential for maintaining herd immunity, which helps protect those who cannot be vaccinated due to medical reasons, such as allergies or compromised immune systems.

#### **Tobacco Use, Cessation, and Prevention**

The Hocking County Health Department's tobacco prevention program is steadfast in its commitment to youth health, focusing on prevention and decreasing the access and availability of nicotine products to youth.

As part of the program's efforts, our staff educates 4th, 7th, and 9th-grade students in the Logan-Hocking School District on the dangers of nicotine products, with a special emphasis on electronic cigarettes. Over the last year, more than 700 students have been educated, paving the way for a healthier future generation.

## **Emergency Preparedness**


Through federal funding made available to the health department, our Emergency Preparedness Division continues to plan for emergency situations, drills, and exercise response plans, and review and update the plans annually with our local and regional response partners. In addition, each year, the Center for Disease Control and Prevention (CDC) requests preparedness activities be completed in exchange for that funding. In 2024, our activities included:

- Retirement of our previous Emergency Response Coordinator, Debbie Elliot, and the addition of a new Emergency Response Coordinator, Ashlee Hagenbarth;
- An increase in recruitment events for the Hocking County Medical Reserve Corps;
- Annual review and update of our training plan to extend to 2028 (Multi-year Training and Exercise Plan);
- A focus on working with Access and Functional needs partners when updating plans and facilitating exercises;
- Multiple trainings for our Emergency Preparedness staff sponsored by the National Disaster Preparedness Consortium;
- Planning for two chemical-based tabletop exercises that will occur in Spring of 2025;
- Exploration and utilization of the Federal Emergency Management Agency's (FEMA) new Resilience Analysis and Planning Tool (RAPT); and
- Evaluation of our Medical Countermeasure (Dispensing) Program using CDC's tool.

#### 2024 Community Health Improvement Plan

In 2023, a Community Health Needs Assessment (CHNA) was completed in Hocking County to evaluate the health issues and health status of the county's population. In 2024, Rural Health Innovations facilitated a collaborative effort, bringing together community stakeholders and the steering committee to examine the results of the CHNA and jointly develop a Community Health Improvement Plan (CHIP).

The CHIP, a comprehensive and long-term plan, identifies health priorities, goals, objectives, and action steps that a community can use to guide them in developing and implementing projects, programs, and policies that aim to improve the health of the residents of Hocking County. This long-term commitment ensures that the health of the community remains a top priority.




